**Other Terms and Conditions**

1. Water furnished hereunder is for the sole use of customer and the selling, furnishing, or permitting of water to third parties is expressly prohibited.
2. Tampering with the meter is expressly prohibited and punishable by law.
3. Failure to pay by the 15<sup>th</sup> of each month, constitutes a late fee of \$8.50 beginning on the 16<sup>th</sup> and subject to disconnection thereafter.
4. If service has been disconnected for non-payment, a \$35.00 reconnect fee will be required prior to reconnection. A 30% additional charge will be added if it becomes necessary to turn your account over to a collection agency.
5. A \$25.00 fee will be added for all returned checks, regardless of the reason.

Trash services are included in your utility bill. Trash is collected Wednesday of each week. Please have trash out by 7:00 am on Wednesday morning. You are responsible for your own trash can, however a recycle can be issued to you upon request. Please note, only one recycle can will be issued per address. We are not responsible for lost or stolen cans. The recycle can will not be dumped if it contains non-recyclable items. Below is a list of items that can and cannot be recycled.



### **Paper - Dry & Clean; Loose** (not in plastic bags)

- Newspaper & inserts
- Magazines & catalogs
- Junk mail, envelopes, file folders
- Office white, colored and computer paper (staples & paper clips ok)
- Corrugated cardboard boxes
- Cereal & gift boxes, etc. that tear brown or grey (remove liners)
- Paper bags & phone books
- Wrapping paper (remove metallic paper, bows etc.)

### **Containers – Empty & Clean; Loose** (not in plastic bags)

- Aluminum cans (beer & soda)
- Aluminum foil & foil plates, etc.
- Plastic bottles, jars, tubs and buckets (such as soda, water, milk, juice, liquor, shampoo, detergent, condiments, salad dressing, yogurt, margarine, pet food, etc.)
- Metal food cans (tin/steel); metal lids
- Metal pots and pans



### UNACCEPTABLE MATERIALS:

- Ceramics, dishes, coffee cups, drinking glasses
- Glass cookware/bake ware (Pyrex, Vision Ware, etc.)
- Window glass, mirrors, light bulbs
- Plastic bags, Styrofoam containers, packaging peanuts
- Take out containers, plastic cups, and plastic table ware
- Containers of hazardous or toxic materials
- Tissue or paper towels, books
- Tyvek envelopes, carbon paper
- Paper cartons for milk or juice
- Wax coated boxes

**Note: Bulk pickup must be scheduled with Republic Waste.**
